This 3-day course covers state-of-the-art methods of identifying, recording, processing and preserving various types of evidence found at the scene of the crime. The program is geared for "Hands-on" use of equipment, materials and supplies necessary for a thorough and comprehensive evidence collection mission.

1) Crime Scene Mission

- Protecting the crime scene

2) Crime Scene Documentation
